Climaflex® XT, supplied under the Pink® Batts® brand, is a polyethylene-based, closed cell, foam pipe insulation. It fits easily around piping (metal and non-metal) providing a thermal resistance (R) of 0.5 at 60°C. When tested to EN13501.1 it meets B1 s1 d0, material group number 1S.

It may also contribute to noise reduction.

Climaflex® XT is manufactured from at least 30% recycled and mass-balanced feedstock, including recycled waste with an organic origin from agriculture, forestry and related industries such as used cooking oil.

Climaflex® XT is manufactured by the Belgian company NMC where is it known as Climaflex® naturefoam. NMC was established in 1950.
